**A JOINT RESOLUTION OF THE CITY COMMISSION OF THE CITY OF
BRADENTON BEACH AND THE COMMUNITY REDEVELOPMENT AGENCY
OF THE CITY OF BRADENTON BEACH, AMENDING RESOLUTIONS NOS.
15-846 AND 16-859, AND AMENDING THE CITY'S BUDGET FOR FISCAL
YEAR 2015-2016; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS, IN ACCORDANCE WITH Section 166.241, Florida Statutes
and Article II, Section 4 of the City of Bradenton Beach City Charter ("City
Charter"), the City of Bradenton Beach City Commission ("City Commission") and
Community Redevelopment Agency of Bradenton Beach ("CRA") adopted a Budget
for Fiscal Year 2015-2016 by Resolution No 15-846; and,**

**WHEREAS, in accordance with Article IV, Section 8 of the City Charter, the
City Commission and the CRA may during the Fiscal Year make appropriation
amendments to the Budget and,**

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
OF THE CITY OF BRADENTON BEACH AND THE COMMUNITY
REDEVELOPMENT AGENCY OF THE CITY OF BRADENTON BEACH,
FLORIDA, AS FOLLOWS:**

**Section 1. Budget Amendment. In accordance with Article IV, Section 8 of
the City Charter, the Final Budget adopted as of Resolution No. 15-846 and
amended with Resolution No. 16-859, is amended and replaced with the Budget
Resolution 16-859 as depicted on Exhibits A and B.**

**Section 2. This Resolution shall become effective immediately upon its
adoption.**


